## SCHOLARSHIP GUIDELINES

### FIVE (5) \$300.00 SCHOLARSHIPS

1. Applicant must have parent or guardian registered in a Catholic Parish in Linn County.
2. Applicant must be a current high school senior or undergraduate student from Linn County.
3. Applicant must apply and be admitted to a full time accredited Junior College, College or University in Iowa.
4. Scholarships are awarded for one academic year. Student may apply for another year upon submission of a new application as long as they meet guideline number two.
5. Applicants **MUST** submit a high school or college transcript to the selection committee. A minimum 2.5 grade point (based on 4.0 system) is required.
6. Applicant must be a citizen of the United States.
7. The scholarship money will be awarded directly to the student upon receiving their class schedule for the second semester. This schedule must be received by **January 15th**.
